In September 2002, the voters of Miami-Dade County approved by voter referendum an amendment to the Miami-Dade County Home Rule Charter ("Charter"), which authorized the Board of County Commissioners to create by ordinance The Children's Trust. The Children's Trust, a 33-member board, was authorized by section 125.901, Florida Statute, which establishes children's services councils in Florida and created by article CIII of chapter 2 of the Code of Miami-Dade County, Florida (the "Code"). Pursuant to section 125.901 and article CIII, The Children's Trust is an independent special taxing district. The Children's Trust is also a County board, as defined by section 2-11.36.1 of chapter 2 of the Code, which was created by amendments to the Charter and the Code.

The Children's Trust is a policy setting board that focuses on meeting the needs of children in Miami-Dade County and their families ("Children"). Specifically, board members are responsible for: (1) carefully considering and identifying the needs of Children; (2) clearly articulating The Children's Trust's priorities and policies to best serve Children as well as implementation and expected outcomes of same; (3) developing and approving a strategic plan to prioritize the areas and investment of Trust funding; (4) regularly reviewing policies and priorities to ensure they are still current and reflect the Children's needs; (5) monitoring board activities by requiring staff to provide regular reports and updates; and (6) ensuring staff is adhering to and held accountable for acting consistently with board policies.

Throughout The Children's Trust's history, board members have received annual trainings conducted by the Miami-Dade Commission on Ethics and Public Trust. Such training provides important information for board members regarding their responsibilities as board members and state and local laws that they are subject to comply with and consequences for violating such laws. However, it would be beneficial to expand the annual training to also include training from the Miami-Dade County Office of Inspector General as well as topics such as the Citizens' Bill of Rights, additional responsibilities of board members, explanation of fiduciary responsibilities of board members, the significance of TRIM budget hearings, Sunshine law,

Background: Young Talent Big Dreams (YTBD) is an annual countywide performing arts competition now entering its tenth year. It is open to all children and youth ages 8-17 residing in Miami-Dade County. Actors' Playhouse is a 501 (c)(3) entity that operates a theater and has 30 years of experience implementing programs for children and youth. In exchange for its financial support, The Children's Trust co-produces the competition and is recognized as the presenting sponsor. Actors' Playhouse has attracted more than 500 children and youth to register for YTBD auditions each year since the competition's inception.

The competition has successfully achieved The Children's Trust's goals of increasing participation in the spoken word and dance categories. Additionally, YTBD has attracted more ethnically and racially diverse contestants with considerably more talent from larger areas in the community than prior years. Over the past year, YTBD participants have performed at the Champions for Children Awards Ceremony, Westland Back-to-school event, the Family Expo and at Marlins Park Night

This funding is in accordance with the procurement policy, section 2008 Community Outreach Activities. In previous years, the grand prize winner has received a free trip – airfare, hotel and passes for two – to attend the live Teen Choice Awards, courtesy of WSVN 7News, along with \$500 in cash and in 2019 Wells Fargo was the final's presenting sponsor.

Description of Services: Actors' Playhouse closely collaborates with The Children's Trust to plan, develop, and execute all aspects of the YTBD competition. Participants compete in a total of six individual categories including pop/rock/rap vocals, musical theatre/jazz standards/classical vocals, dance, musical instrument, original spoken word and original vocal and/or instrumental composition. Categories for groups of six or fewer members include dance, musical instrument/bands and vocal. The competition consists of several auditions

held throughout Miami-Dade County, and semifinal and final competitions. Actors' Playhouse manages the coordination of the competition's many moving parts, which include: 1) securing audition venues, either at a reduced cost or free; 2) overseeing all audition sessions; 3) recruiting dozens of professional volunteer judges; 4) producing the semifinal and final shows; 5) soliciting and securing the donation of masterclasses and other prizes for participants; and, 6) promoting auditions and the semifinal and final shows.

Background: The printing and distribution of The Children's Trust's monthly parenting newsletter is a detail-driven, precisely timed project. It involves production and delivery of the newsletter to 85 different locations, reaching more than 22,000 readers. In response to a request for quotes, two qualified vendors provided quotes. Rex Three, Inc., was selected for this service because of its past performance and experience in consistently and reliably fulfilling complex print work. Specifically, The Children's Trust regularly uses Rex Three, Inc., for print services. It has always performed with excellence and provided timely, reliable, and professional services.

Description of Services: Rex Three, Inc., will be responsible for printing, sorting, boxing, labeling, and prepping for delivery of The Children's Trust's monthly parenting newsletter, a trilingual publication (English, Spanish, and Creole), distributed to 85 locations throughout Miami-Dade County, including after-school programs, childcare centers, faith-based institutions, and others.

October 1, 2019, and ending September 30, 2020.

Budget Impact: Funding in the amount of \$110,000.00 for this resolution is

allocated for FY 2019-20.

Background: The Florida Children's Council, Inc., (FCC) is a statewide non-profit organization whose members consist of nine Children's Services Councils (CSC or Council): CSC of Broward County, Kids Hope Alliance (Jacksonville), CSC of Palm Beach County, CSC of Martin County, CSC of St. Lucie County, The Children's Trust, the Children's Trust of Alachua County, the Hillsborough Children's Board and Manatee Children's Services. By engaging and enhancing the collective strengths of the individual CSCs, FCC promotes policies that build effective prevention and early intervention systems of supports for Florida's children and families. Among other things, the FCC: (1) provides an umbrella for leadership, coordination and centralized management; (2) promotes and supports the needs of children and their families; and, (3) advocates and lobbies state-level for policy decisions to support communities, children, youth, and their families.

In its mission to promote policies that build effective prevention and early intervention systems, the FCC focuses on the four key areas below:

- Advocacy Advance a prevention and early intervention agenda for children at state and national levels.
- Awareness Educate local communities, policymakers, businesses, community leaders, and other organizations about the work and worth of CSCs.
- Relationships Build productive partnerships with individuals and organizations interested in making smart, strategic investments in Florida's children and their families.
- Expansion Help communities maximize their return on investment through peer learning and resource maximization and by establishing children's services councils in additional counties.

The FCC is located in Tallahassee, Florida. Each Council is assessed membership dues based on a percentage of their annual tax revenues to support the FCC's operating expenses, including salaries. The Children's Trust has been a member of the FCC since 2004. Last year, The Children's Trust membership dues were calculated as a 0.012 percent of the 2018-19 projected revenues, resulting in the membership fee of \$132,513.00 for The Children's Trust. This year, a new membership fee structure was negotiated. The new fee calculation is a tiered structure based on total ad valorem collected, as follows:

- Tier 1: Up \$20,000,000.00, fee = \$12,000.00 per year
- Tier 2: \$20,000,001.00 to \$50,000,000.00, fee = \$25,000.00 per year
- Tier 3: \$50,000,001.00 to \$100,000,000.00, fee = \$80,000.00 per year
- Tier 4: \$100,000,001.00 and up, fee = \$110,000.00 per year

The 2019-20 membership dues for The Children's Trust is \$110,000.00, which is a 17 percent (\$22,513.00) decrease from the previous year.

Per the procurement policy, Section 2000 – G-8, Exemptions to Formal Competitive Procurement Process, this expenditure for membership dues is exempt from the competitive solicitation process.

Description of Services: Approval of this action is essential to the continued operation of the FCC. The FCC serves as the unified messenger on behalf of all member CSCs and the interests of the hundreds of thousands of children and families they collectively represent. The FCC develops a unified legislative strategy to ensure that Florida's children are healthy, safe, and successful in school with the help of its policy staff and membership expertise.

The Children's Trust plays a vital and active role in statewide advocacy. Part of its success comes from its collaboration with other CSCs in pursuit of a common legislative agenda on issues such as early childhood education and care, children's safety, children's health, the child welfare system, and juvenile justice. The FCC is instrumental in the Councils' cooperative endeavors. Collectively, the Councils have reached a level of significant investment and success in investing local resources in evidence-based services, which positions the councils to exert meaningful influence on state policies affecting children and families through statewide advocacy and dissemination of evidence-based literature. Collaborative efforts with state leaders are key in the development of a long-range policy plan to strengthen crucial supports and resources that address hunger, transportation, housing, workforce development, health, education, and early intervention services for children and families, particularly those living in poverty. In this work, the FCC maintains active relationships with leaders in the executive and legislative branches that further the Councils' collective work.

The FCC aims to make a difference in the lives of children by strengthening and expanding the work and mission of CSCs. A snapshot of the FCC's work during FY 2018-19 is provided below:

- Eighty percent of the legislative items the FCC advocated for were approved during the 2018-19 legislative session.
- The FCC hosts an annual meeting of senior leadership and key staff members from the CSCs to provide opportunities to engage in community sharing on work areas essential to child, youth, and family services including finance, research, program, public policy, and communications.
- The FCC hosts an annual Legislative Meeting in Tallahassee in preparation for the Legislative Session, in which the Council Board meets with Legislators, Agency

- Secretaries and Directors, and other influential leaders to discuss continued partnership throughout the state on issues affecting children and families. This helps to strengthen relationships and is crucial during leadership transitions in order to inform new leaders about the critical work of individual CSCs and the collective work across the state.
- To expand the work of CSCs throughout the state, the FCC serves as a resource for counties to collect information from other CSCs, conduct presentations on the outcomes and impact of CSCs, provide information and advice on procedural items, and more. This year, the FCC worked in partnership with community leaders from Lee County, Leon County, Putnam County, Orange County, and others that are exploring referendum opportunities for establishing new Children's Services Councils.
- The FCC continues to work with community and state partners and the National Grade-Level Reading Campaign to create a statewide movement to ensure all children read on grade-level by the end of third grade through promoting school readiness and quality instruction, tackling chronic absenteeism, and improving summer learning, as well as engaging parents as their children's first teachers.
- The FCC served as the technical expert and leader, in partnership with the Early Learning Consortium, to research and identify opportunities for more effective public policy supporting kindergarten readiness and early grade success. This resulted in two legislative bill packages that both successfully passed in consecutive legislative sessions.
- The FCC worked to implement two-generational approaches to serving low-income children and families by supporting the Florida Healthy Kids Corporation (FHK) legislative request to fund full-pay FHK health insurance plans. As result of the unified advocacy effort, funding was provided in the General Appropriations Act, SB 2500, to fund the FHK Corporation budget request that will lower the cost of health insurance for families in its full-pay program. This will lower the cost for approximately 15,000 children currently enrolled, and about 146,000 uninsured children will have access to a more affordable health care plan. Additionally, the FCC received funding from partners of the Wellspring Philanthropic Fund to support 24 months of continued work in this area. This funding will allow the FCC to identify state system alignment strategies that would result in more effective services for children and families.
- The FCC received an award from the National League of Cities to hold a Mayoral Summit on Afterschool and Summer Learning. The event engaged civic and municipal leaders from more than 80 cities in Florida including mayors and legislators. It was a highly effective forum for increasing awareness of how afterschool programming can benefit local communities and help mayors and municipalities be more successful.

a contract with Healthmaster Holdings, LLC; authorization for a waiver to the competitive solicitation process for a software as a service (SaaS) solution to track school-based health clinic interactions; and authorization to negotiate and execute a contract with Education Health, LLC, d/b/a Healthmaster for the SaaS solution, in a total amount not to exceed \$200,000.00, commencing October 1, 2019, and ending September 30, 2020, with three possible 12-month renewals, subject to annual

funding appropriations.

Budget Impact: Funding in the amount of \$200,000.00 is allocated for FY 2019-

20.

Background: On June 17, 2019, through resolution #2019-78, the board of The Children's Trust approved a contract renewal with Healthmaster Holdings, LLC, to provide a SaaS solution to track the school-based health clinic interactions. Healthmaster Holdings, LLC, was selected as part of a competitive request for qualifications (RFQ) #2018-10 which was initially approved at the October 2018 board meeting.

On August 16, 2019, Healthmaster Holdings, LLC, notified The Children's Trust of their company buyout by Education Health, LLC. As of October 1, 2019, Education Health, LLC will commence using the d/b/a Healthmaster. Education Health, LLC, has its own Federal Identification number which will be used when the contract is executed. Services will not be affected by the acquisition as Education Health, LLC, d/b/a Healthmaster now owns the license to the SaaS solution.

Request for Procurement Waiver (requires approval of a 2/3 vote of board members present): This resolution is requesting a waiver of the procurement process and is seeking the authorization to negotiate and execute a contract with Education Health, LLC, d/b/a Healthmaster to provide the SaaS solution to track services provided by the school-based health organizations funded by The Children's Trust. Healthmaster Holdings, LLC, the agency originally selected through a formal competitive solicitation, was acquired by Education Health, LLC, d/b/a Healthmaster. Through the acquisition, Education Health, LLC, d/b/a Healthmaster is now the license owner of the software procured through the competitive solicitation. In the past year, The Children's Trust has worked closely with Healthmaster to customize the new software, execute a data sharing agreement with Miami-Dade County Public Schools and train all school health staff on the new system. Additionally, the selection

of Healthmaster's SaaS solution allowed The Children's Trust to realize \$300,000.00 in cost savings as the prior solution was \$500,000.00 per year.

Description of Services: Education Health, LLC, d/b/a Healthmaster will host, maintain and provide support for an electronic school-based health system and database. Education Health, LLC, d/b/a Healthmaster will also provide help desk support and training as requested by The Children's Trust and the contracted end users. The system will support no less than 300 users distributed across 141 school-based health clinic sites. Encounters to be tracked include clinic visits, screenings, health education, and chronic disease management.

Budget Impact: There is no budget impact for this action.

Background: The Children's Trust issued requests for qualifications (RFQ #2019-07 and RFQ #2019-08) in February of 2019 seeking applicants for the creation of new vendor pools for communications and IT services. The RFQ process resulted in 21 communications vendors and ten IT vendors being recommended to be part of the vendor pools across a wide range of expertise in various areas. The Board of The Children's Trust approved these recommendations on May 20, 2019, through resolutions #2019-67 and #2019-68.

Once the vendor pools were created, per The Trust's procurement policy, vendors were to be selected from the existing pools through an expedited bid process. Bids were sought for projects or ongoing work utilizing defined scopes of services with entities within the approved vendor pools. After the vendor pools were established, and in consultation with the County Attorney's Office and the Miami-Dade County Commission on Ethics and Public Trust, it was determined that errors occurred during the vendor selection process.

After further review, The Children's Trust deems the vendor pool process to be unnecessary for these services as it would result in two separate formal competitive solicitations, which was not the original intent when the vendor pools were created. It will be more efficient to procure these services through requests for proposals that negate the creation of vendor pools, for the needed services where all interested vendors can compete.

Description of services: This resolution authorizes The Children's Trust to dissolve the existing vendor pools and to release RFPs for communications and IT services across a wide range of categories as shown in the following table.

Background: In April 2018, The Children's Trust Board approved funding for Hosanna Community Foundation to implement the Evidence2Success initiative in Liberty City. Evidence2Success is an initiative introduced and partially funded by the Annie E. Casey Foundation which invests in local community efforts that help community residents decide which programs are available to them through a series of community meetings.

The intent of the Evidence2Success initiative is to focus on improving the well-being and development of children and youth by soliciting their input about issues they face. Once issues are identified, the Evidence2Success initiative uses an evidence-based approach to convene local government officials, clergy, school district employees, local funding agencies, community organizations, and community residents to determine which programs will best suit the community and identify the agencies to implement them. This is done by first partnering with the school district to collect data from middle and high school youth and meeting with local funders, government entities and community organizations to identify the programs that currently exist in the community. Based on the information collected, the community decides the next steps. Examples include: ensuring residents are aware of services in their community; writing grants to bring additional programs to the community; and expanding existing programs.

As the initiative entered year two, Hosanna Community Foundation encountered challenges engaging the necessary public officials and community stakeholders, resulting in difficulties gaining access to the various schools to conduct the youth surveys required by the Annie E. Casey Foundation. As a result, the Annie E Casey Foundation decided to find another local entity to co-lead this effort. The agency chosen was the Miami Children's Initiative (MCI). Year two of Evidence2Success started in January 2019 and entails convening the various stakeholders mentioned above to start conversations about the programs currently available in the community; gaining access to the middle and high schools for the youth surveys to be administered; and getting input from the community residents to determine what programs are needed in the community.

Description of Services: The Evidence2Success framework includes the engagement of community residents in decision-making and action alongside agency leaders. The three-year

Evidence2Success roadmap allows the data-driven partnership to better understand how children are doing in their well-being; select proven evidence-based programs to enhance strengths and address needs; and, develop financing and action plans to support the ongoing use of these community evidence-based programs.

Evidence2Success is currently in the second year where a community board, reflective of the Liberty City population, is formed and prepared to lead Evidence2Success. The Evidence2Success board will:

- learn about prevention science and strategic financing;
- deepen its knowledge of local context in partner neighborhoods and participating public systems and related disparities;
- write a vision statement and formulate key messages about Evidence2Success in neighborhoods and public systems;
- create a board structure and form workgroups;
- develop a timeline for installing Evidence2Success that considers key public systems budget and planning dates/cycles;
- begin fund mapping; and
- begin to engage a wider group of stakeholders.

Key Biscayne Community Foundation will be the fiscal agent, providing in-kind services in the amount of \$50,000.00, for this effort going forward. MCI will serve as the lead agency to convene the public officials and community stakeholders and work with Miami-Dade County Public Schools to conduct the youth surveys in the Liberty City area middle and high schools. The Children's Trust will fund a site coordinator at MCI who will convene the numerous community meetings, manage the day-to-day of the effort and complete the necessary grant reporting requirements. Key Biscayne Community Foundation and Himan Brown will fund and raise the additional dollars needed to implement the programs once they are identified.

This investment represents the second year of funding for Evidence2Success. For every dollar The Children's Trust invests in Evidence2Success, \$3.00 is invested by the funding partners as described in the table below.

30, 2020.

Budget Impact: Funding in the amount \$100,000.00 for this resolution is allocated

for FY 2019-20.

Background: The Fab Lab is an effort by Key Biscayne Community Foundation to expand access to STEM (science, technology, engineering and math) to the children of Liberty City. Key Biscayne Community Foundation has been successful in raising funds from Himan Brown Charity Trust and an anonymous foundation. This investment complements The Children's Trust's match contract with the Miami-Dade Library System, bringing STEM opportunities directly to our communities. Funding both initiatives allows for scale at a faster rate. Because the Fab Lab is mobile, there is an opportunity to move the lab to other Trust-funded providers in the Liberty City area.

Description of Services: The Fab Lab is a mobile unit initially designed for communities as a prototyping platform for local entrepreneurship. Educators are increasingly using Fab Labs as platforms for project-based, hands-on STEM education. Users learn by designing and creating objects of personal interest or import. Additionally, users are empowered to both learn and mentor each other, gaining in-depth knowledge about the invention, the materials, the design process, and the engineering that goes into creativity and innovation. In educational settings, rather than relying on a fixed curriculum, learning happens in an authentic, engaging, personal context, in which students go through a cycle of imagination, design, prototyping, reflection, and iteration as they find solutions to challenges or bring their ideas to life. The collaborative will begin with one Fab Lab mobile unit to be stationed at the Liberty City Optimist Club, located in Charles Hadley Park at 4900 NW 12th Ave, Miami, FL 33127.

The Fab Lab mobile unit uses different types of technologies. Some of the hardware technologies can be found at local hardware stores or purchased from specialty companies. The software used is often an open source, allowing free access, and some of the products are written by researchers at MIT's Center for Bits & Atoms. This solution not only teaches children about technology but uses technology that is accessible to them.

The Fab Lab mobile unit currently includes the following materials:

- laser cutter that makes 2D and 3D structures;
- sign cutter that plots in copper to make antennas and flex circuits;
- high-resolution CNC milling machine that makes circuit boards and precision parts;
- large wood router for building furniture and housing; and
- suite of electronic components and programming tools for low-cost, high-speed microcontrollers for on-site rapid circuit prototyping.

The Fab Lab unit will support the Liberty City Optimist Club's Youth Development programs currently funded by The Children's Trust. The anticipated outcomes for 105 youths are:

- 25 percent increase in the number of participants who see themselves in a STEM job or career;
- 20 percent increase in the number of participants will take more STEM classes in the future; and
- after completing the eight weeks-curriculum, 80 percent of students will feel comfortable using the tools in a fabrication laboratory.

This investment represents the first year of Children's Trust funding for the Fab Lab. Key Biscayne Community Foundation will be the provider of services in partnership with Collective Empowerment Group of South Florida, Liberty City Optimist Club, and Teen Outreach Program. Additional partners in the Fab Lab include an anonymous foundation.

For every dollar, The Children's Trust invests in the Fab Lab program, \$3.60 is invested by the funding partners as described in the table below.
